

A Letter from the President:

If 2019 showed us anything, it is that rock climbing isn't just a passing fad. Last year we saw some of the biggest crowds in our parking lots, trails, and crags. The community found out about a plan to build a resort next to natural bridge state park and we saw many new businesses open in response to the growing demand. Even in the colder weekends of the winter, usually empty walls saw crowds.

Our mission at the RRGCC is securing and protecting open, public access to rock climbing in the Red and promoting conservation of the environment on the lands where we climb. With the tremendous growth and popularity of climbing, this mission has become more challenging. Last year we furthered out Gym-to-Crag programs with the intent of educating new climbers, and old, on some of the ways in which the users of RRGCC lands can help us further our mission.

We can't do it alone. I'd like to take a second to say thank you to our supporters for helping to further protect the land we all know and love. Thank you to the person who speaks up at the parking lot, gently reminding out of towners that they shouldn't block oil equipment or the road. Thank you to the group that asks the over rambunctious dog's owner to please leash their pet. Thank you to the people I see cleaning up micro trash at the crag and taking a last look before leaving an area to make sure they left no trace. A huge thank you to all of our volunteers and supporters. Maintaining the trails, roads, and bridges we sometimes take for granted is a HUGE effort and we couldn't do it without your help.

A quick drive down 11 shows a lot of changes to our little corner of Eastern Kentucky. With these changes, we, as a community, will continue to change. I feel we have done a great job organizing the crowds and limiting impact and we will continue to do it with your help. We will continue to promote responsible climbing and land use. We have 10+ gym-to-crag presentations planned for this year. If you would like to see one at your gym please let us know.

Speaking of changes, our Executive Director, Ashlee Milanich, accepted a job with the American Alpine Club last year. Ashlee was an integral part of the RRGCC. She ran many of the Gym-to-Crag presentations and organized all of the logistics. She also organized and ran all Coalition events including Rocktoberfest. Ashlee will be sorely missed but we are all very excited for her in her new position. If you know Ashlee or see her around please thank her for her tireless effort in helping the RRGCC further our mission. Ashlee, thank you so much for everything you did for the coalition -- I know you will be awesome at the AAC. They are lucky to have you.

Rocktoberfest 2019 was, yet again, a huge success. The festival saw over 1,000 attendees, 35 sponsors and 13 clinics. The proceeds from RF were over \$50,000. That money will be used to help pay on our mortgage for Bald Rock Fork and maintain trails and roads to the other RRGCC lands. This year showed the return of the crowd favorite Dyno Competition. Thank you to Justin Minard and Kris Hampton for putting on an awesome show! The forest service and the RRGCC also signed a Memorandum of Understanding to better coordinate on access, trail projects, natural resource education, and mitigating climber's impact.

Climbing is inherently dangerous. Nothing cemented that more, for me personally, than the loss of Marty Vogel last year. Marty was a huge supporter of the RRGCC, The RRG Fixed Gear Initiative, Muir Valley and the Red in general. Marty's death hit us at the RRGCC particularly hard. He was a mentor, friend, and inspiration to more people than I can count. Marty's loss will be felt for years. The RRGCC has communicated with other organizations in the area and we plan to memorialize Marty's legacy. We are still working out the details and will update the community when more information is available.

In the new year the RRGCC plans to continue educating new climbers with our Gym-to-crag programs. We will also continue to search for new land that fits with our mission of protecting climbing in the red. We will work with the forest service to try to identify areas that have potential new climbing where it does not impact archaeological artifacts and/or endangered species. We are also supporting a second economic impact study to gather new numbers to compare to the previous one.


Routes in 1998 Bronaugh Guidebook: ≈ 1,000







Treasurer's Notes:

Bald Rock Fork Payoff

In 2017 the RRGCC established the Bald Rock Fork Recreational Preserve (BRRP) with the purchase of the land surrounding the Motherlode, Chocolate Factory, & Bear's Den. This was funded in part with a \$225,000 loan from the Access Fund.

We have made great progress towards paying off this loan with almost \$175,000 repaid over three years. We have \$51,000 to go which we plan payoff in 2020.

This will mark the third successful climber-funded land acquisition in the Red River Gorge. This purchase was made possible by our donors, corporate sponsors, and the Access Fund's Climbing Conservation Loan Program.

Grants & Reserved Funds

When the RRGCC receives a grant there may be stipulations as to how those funds may be used. In those cases, we hold and track those funds separately to ensure they are used solely for their designated purpose.

Currently, we have reserved funds from the Arches Foundation for use in building and maintaining pit toilets. We have installed one toilet in Miller Fork and have plans for a second in Bald Rock Fork.

Conservation Easement

The RRGCC and Access Fund recorded two permanent easements to strengthen conservation and recreation protections at all three climbing areas owned by the Coalition.

The Access Fund now holds permanent conservation and recreation easements on the properties, providing backup and support for RRGCC's long-term commitment.

The RRGCC pledged \$20,000 to the Access Fund to support the upfront legal costs and on ongoing maintenance expenses for holding the easements. The second half of this pledge is due in 2020.

Grants Awarded for 2020

Access Fund Climbing Conservation Grant

With a \$2,000 matching grant from the Access Fund we are supporting Dr. Maples and his team at Eastern Kentucky University with an update to the economic impact study of rock climbers in the Red River Gorge area.

American Alpine Club Cornerstone Conservation Grant The RRGCC was awarded a \$6,000 grant for trail development, belay base reinforcement, and conservation work on a new crag that will hopefully be announced later this year.
