A Letter from the Director:

What did I promise last year? Probably something crazy like going to the moon. Well, between the painkillers my doctors prescribed when I broke my leg and the productivity everyone else had, I'd say we got pretty close. Access Fund must have thought so too, recognizing the RRGCC with a **Land Conservation Award** for paying off the BRRP. Overall, **2022 was a year of capital projects** & **big-picture management planning**, on top of another round of kickass events and fundraising. You can thank our Board of Directors, land management team, & volunteers for putting in the hard work to make this happen, but don't forget to pat yourself & your fellow donors on the back for supporting the RRGCC and its mission. For that, we thank YOU!

We started off with a much needed overhaul of the **Coal Bank hollow access road** & **parking lot**, subsidized by a **Climbing Conservation Grant** from **Access Fund** for \$3,500. By the time summer was cooking, a torrential downpour triggered flash flooding throughout the Gorge, **washing out many of our bridges** & **parts of the Miller Fork road.** Either I brought bad luck the past three years or AI Gore was right. In any case, an added culvert & some hefty grading got things back in shape. Meanwhile, over in PMRP, these rain events the past few years were **cutting the Drive-By parking lot in half**. So we sent in the backhoes one more time to fix the drainage flowing straight into the lot and patch up the ever-growing fissure. With each of these projects, we look to **not only repair, but improve** each area so that they can better withstand the wear for years to come.

Improvements didn't end with road work; however, as we collaborated with a number of conservation groups, LCOs, & government agencies on our growing management reach. I attended Access Fund's third 'Future of Fixed Anchors' conference in Utah this past summer, gleaning all sorts of knowledge regarding route development policies, re-bolting, rope access safety, & federal management plans. Upon bringing this back to Kentucky, our Access committee released a new route developer MOU for bolting on our properties and intend to look more closely into re-bolting efforts around the Gorge. Beyond that, RRGCC worked with the Forest Service on its new Red River Gorge management plan to ensure crag stewardship projects were included. And lastly, RRGCC & Muir Valley sent nine folks to Access Fund's Climbing Advocacy Conference to discuss our most pressing issues in the LCO world & how to improve upon these topics in the Gorge. Both our DEI chair, Briana, and I presented about protecting cultural resources & the economic impact of climbing, respectively.

Our DEI committee keeps plowing forward, growing our Climb L8 program inside and even sending it outside for the first time — Rock L8! We hosted **16 free climbing events** with our regional gym partners and added **two free outdoor trips** right here in the Red River Gorge, one supported by a grant through **Climbing for Change** & the other from our friends at **Muir Valley**. Other events rolled on, with Rocktoberfest growing to such a juggernaut that I may have overbooked the amount of space we had available at Land of the Arches. Sponsors & climbers flocked from across the globe to the tune of **\$100,000 in gross revenue!**

Well I'm about to run out of space, but not before I mention the incredible work our land management collective pulled together in 2022. Through a grant from **Athletic Brewing**, Access Fund was able to send its amazing Conservation Team to tackle the massive project of **fixing the belay base near 'Monobrow' at Rival Wall.** Additional stone terracing also improved erosion control at Bronaugh wall, Playground, & the Nursery. New bridges were installed at Chocolate Factory, Fruit wall got a new trail to its left side, Patagonia ambassadors even helped with a huge, ongoing project at Chica Bonita. There is way more out there, so go enjoy it for yourself and remember to **sign up as an RRGCC member** so we can keep this train rolling!






Bolting & Route Development

Update from the Land Manager:

With the BRRP mortgage paid off last year, we were able to funnel some extra cash toward stewardship projects for our roads, trails, & crags in 2023. Some of our biggest infrastructure benefited greatly, with road work in the Miller Fork, Coal Bank, & Drive-By areas. A few grants helped move other stewardship projects along as well, with major belay base work at Rival Wall thanks to Access Fund's Conservation Team & Athletic Brewing!

JATD also finally returned to it's normal, one-day format with over 100 volunteers & 12 successful projects across our properties! Many of these projects had instant impacts, while others were part of larger trail or crag overhauls.

There is always more work to be done, so keep an eye out for volunteer opportunities and some of our new projects coming up in 2023!

- Three weeks of rock terracing to rebuild Rival wall belay base
- New bridges at Chocolate Factory
- Erosion control projects at Bronaugh wall, Playground, & the Nursery

- Repair Drive-By parking lot and improve drainage

Education DEI, and Outreach

Climb L8

Gym initiative which exists to remove systemic and financial barriers to entry into rock climbing and facilitate a safer space in the rock climbing gym for Black, Indigenous, people of color, LGBTQIA+, adaptive, first time climbers, and those without financial means. The goal of Climb L8 is to work to break down those barriers in climbing and bring people together by building community, empowering and amplifying underrepresented voices, and making space to learn together.

Climb L8 offers free admissions and rentals at partnering local climbing gyms for the communities described above.

- 16 events in three states serving over 300 individuals
- Partnering with Climb Time Oakley, Rock Quest, North Mass Boulder and LEF Climbing
- Received thousands of dollars in donations from Ale 8 One, Muir Valley, Access Fund, and many others.

Rock L8

Gym to the Crag initiative which exists to introduce first time climbers and those from marginalized backgrounds to the sport of outdoor rock climbing in the Red River Gorge.

- Hosted 2 Outdoor trips in 2022
- Partnered with local businesses and nonprofits to make the trips possible
- Introduced over 30 individuals to rock climbing in the Red River Gorge.

Gym-to-Crag

In depth discussions about what to expect for your first time climbing outside and how to be a good steward of the land.

- 7 Gym to Crags in 2022
- Connected with 2 universities, 4 climbing gyms, and hosted one virtual presentation.
- Created educational videos on Gym to Crag ethics with a grant we received in 2021 from Access Fund.

The Opportunities Ahead In 2023

- In 2023 we plan to host 18 Climb L8 events, providing free climbing in Lexington, Cincinnati, and Indianapolis.
- Introduce 30 individuals from marginalized and underrepresented communities to outdoor rock climbing in the Red River Gorge.
- Host at least 6 Gym to Crag events, connecting with local gyms, climbing clubs, and universities across the tri-state.




